PRIMEX EXPERIENCE IN THE HEALTH SECTOR

PRIMEX has been doing work in the health sector since the early 1990s. Its first ever health project was also ADB's first health sector project in the Philippines, i.e., *Preparing the Integrated Community Health Services Project (ICHSP) (TA 1891-PHI)* of the Department of Health (DOH) in 1993-1994. Since then, **PRIMEX** has carried out a large number of assignments in the health sector in the Philippines and overseas and has fielded health experts in project midterm and completion missions in the Asia-Pacific region, mostly for the Asian Development Bank (ADB). **PRIMEX** currently holds six Framework Agreements with ADB's Central and West Asia Division (CWSS) for the services of a Senior Health Specialist and a Senior Health Economist in health sector assessments, project scoping and preparation, and evaluation.
